

PRAGUE RHYTHM 2025 (27th Prague Workshop on Catheter Ablation) TERMS AND CONDITIONS OF ATTENDANCE AND PARTICIPATION

These are the terms and conditions (the "Agreement") governing your participation in the 27th Prague Workshop on Catheter Ablation - PRAGUE RHYTHM 2025 on May 18–20, 2025 (the "On Site Meeting and Virtual Event in one" / "Hybrid Event" – shortly "Event"). By registering for the Event you agree to these terms, which form a binding legal contract between the Event owner and host, Endowment Fund HEART ("Endowment Fund HEART" or "Organiser") and the registered participant ("you" or "Participant"). If you are registering on behalf of another individual, it is your responsibility to ensure the person participating is aware of these terms and accepts them. By completing the registration on behalf of another individual you are warranting that you have made the Participant aware of these terms and that you have accepted these terms.

1. Participant Requirements

- 1.1 Access. Your registration entitles you to access to the "Event" for which you have registered. Any and all other costs associated with your attendance shall be borne solely by you, and "Organiser" shall have no liability for such costs.
- 1.2 Use of Likeness. By participating in the "Event" you acknowledge and agree to grant "Organiser" the right to record, film, live stream, photograph, or capture your likeness in any media now available or hereafter developed and to distribute, broadcast, use, or otherwise globally to disseminate, in perpetuity, such media without any further approval from you or any payment to you. This grant to "Organiser" includes, but is not limited to, the right to edit such media, the right to use the media alone or together with other information, and the right to allow others to use or disseminate the media.
- 1.3 "Event" Content. You acknowledge and agree that "Organiser", in its sole discretion, reserves the right to change any and all aspects of the "Event", including but not limited to, the "Event" name, themes, content, program, speakers, performers, hosts, moderators, venue, and time. The "Event" content shall be recorded by Endowment Fund HEART and will be accessible to registered Participants.

2. Prohibited Conduct

- 2.1 Limitations on Use. By registering for the "Event" you agree not to sell, trade, transfer or share your access link and/or code, unless such transfer is granted by the Organiser. If the Organiser determines that you have violated this policy, the Organiser may cancel your access, retain any payments made by you, report you to law enforcement authorities, and ban you from future Events.
- 2.2 Disruptive Conduct. You acknowledge and agree that the Organiser reserves the right to remove you from the "Event" if the Organiser, in its sole discretion, determines that your participation or behaviour create a disruption or hinder the "Event" or the enjoyment of the "Event" content by other attendees.



- 2.3 Recording, Live Streaming, and Videotaping. Participants may not record or broadcast audio or video of sessions at Endowment Fund HEART Event.
- **2.4 Unethical/Non-Compliant Business Practices.** The Organiser reserves the right to deny participation to anyone who engages in or is reputed to engage in unethical or non-compliant business practices.

3. Fees and Registration

3.1 REGISTRATION FOR CONGRESS CENTER IN PRAGUE - ON SITE MEETING

Registration will be processed on first come first serve basis. Capacity of the lecture hall is limited, late or onsite registrations might be refused for capacity reasons.

3.2 REGISTRATION FOR VIRTUAL EVENT

Registration with no amount limits. Via electronic registration form placed on the workshop website. After the payment of your registration, you will receive an access code by an e-mail.

For the Virtual Event access you need the valid registration.

3.5 PAYMENT AND CANCELLATION CONDITIONS

5.4 Personal Data that you provide to us
